#### SCHOOL REFUND POLICY

Any course change or cancellation must be notified by the student in writing to St. George International College (SGIC). Under no circumstances are application fees, homestay placement fees, medical insurance fees, and incoming/outcoming banking fees refunded. If the student registered through an agent, then the refund must be collected from the agent, and St. George International College (SGIC) is not responsible for additional charges incurred by the agent.

#### Rejected Visa(without Provincial Attestation Letter - PAL)

If the student is refused a student visa by the Canadian Consulate in his/her country, the student is entitled to a full tuition fee refund minus a registration fee of C\$200 and/or homestay registration fee of C\$230 and/or medical insurance fee of C\$3.25 and incoming/outcoming banking fees. Students must provide the original visa rejection letter from their local consulate before the start date of their program. The refund will be processed within 45 business days.

If the documented proof is presented on the student's start date, students are eligible for a 60% refund, less the registration fee of C\$200 and/or homestay registration fee of C\$230 and/or medical insurance fee of C\$3.25 and incoming/outgoing banking fees.

If documented proof is presented after the student's start date NO REFUNDS will be made.

After the approval of a student visa by the Canadian Authorities, no refund will be made if the applicant does not come to college or does not study due to personal reasons after the program's start date.

#### **Admission Deferral**

If a deferral is intended, the student must notify St. George International College (SGIC) in writing to defer his / her starting date of classes4 weeks in advanced. If a request to change the start date is made within 4 weeks of the program start date, the refund will not be available, and a non-refundable processing fee of C\$300-500 will apply (varies depending on the promotion and program).

Provincial Attestation Letter (PAL) Refund Policy - Programs from 26 weeks and up If the student is refused a student visa by the Canadian Consulate in his/her country, the student is entitled to a full tuition fee refund minus registration fee of \$200 and LOA (Letter of Acceptance) fee of \$500. Students mush provide the original visa rejection letter from their local consulate before the start date of their program.

#### Homestav

All homestay fees excluding the placement fee of \$230, will be refunded to the student only when the student provides written notice of a cancellation at least 4 weeks prior to the homestay start date. If no written notice of cancellation is provided, the placement fee plus one month of the homestay fee will be withheld. Only the remaining balance after the above deductions can be refunded upon receipt of the student's written request.

The refund will be processed within 45 business days.

If documented proof is presented after the student's start date no refund will be made.

In the event of cancellation due to personal reasons and the student has received PAL, SGIC regrets to inform you that NO REFUNDS will be provided.
